Charles County Bill 2022-14 Weapons and Firearms Prohibited on County-owned or Operated Property **OPPOSITION** to this proposed Bill.

Testimony of Michael Burke

01/11/2023

I stand in opposition to this proposed bill as it violates the US Constitution, 2nd Amendment, which states:

A well-regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed.

This proposed bill also violates the text and language of Maryland Code Section 4 203- that long-established State law outlines an individual's rights to a handgun. While there is a long list of exceptions, this section states that an individual is prohibited from wearing, carrying and knowingly transporting a handgun, whether that handgun is concealed or out in the open. Therefore, possession of a handgun ANYWHERE in Charles County is already PROHIBITED for most citizens.

While this is the general law, a man or woman serving as law enforcement is granted the right to wear, carry and transport a handgun while on active duty. This includes:

State and out-of-state police officers

United States armed forces personnel

Correctional officers / warden at a correctional facility

Others exempt from the law include:

Individuals transporting a handgun from point of legal purchase or to a repair shop

Those engaging in military activity, target practice, hunting, safety classes, etc.

Those carrying the handgun on their own property business or residential.

Those issued a permit under Title 5, Subtitle 3- Handgun Permits – Sections 5-301 through 5-314.

5-303: A person shall have a permit issued under this subtitle before the person carries, wears, or transports a handgun.

This proposed statute does nothing to promote or protect public safety or serve any other purpose other than a direct infringement on those citizens who possess a valid Handgun Permit (HGP) issued by the Maryland State Police (MSP).

Citizens who HAVE a valid HGP have taken extensive firearms training, have submitted their fingerprints, photographs and extensive personal information to the MSP and have PASSED a rigorous background investigation by trained Troopers, Detectives and Investigators at MSP Licensing Division. These are the LEAST likely individuals to pose a threat to anyone's safety.

Under the recent Supreme Court Decision issued this June, 2022, NEW YORK STATE RIFLE & PISTOL ASSOCIATION, INC., ET AL. v. BRUEN, SUPERINTENDENT OF NEW YORK STATE POLICE, ET AL. (aka Bruen), the Court reviewed the question of the right of citizens to bear arms in self-defense.

The State of New York (and Maryland) makes it a crime to possess a firearm without a license, whether inside or outside the home. An individual who wants to carry a firearm outside his home may obtain an unrestricted license to "have and carry" a concealed "pistol or revolver" if he can prove that

"proper cause exists" for doing so. N. Y. Penal Law Ann. §400.00(2)(f). An applicant satisfies the "proper cause" requirement only if he can "demonstrate a special need for self-protection distinguishable from

that of the general community." E.g., In re Klenosky, 75 App. Div. 2d 793, 428 N. Y. S. 2d 256, 257.

Petitioners Brandon Koch and Robert Nash are adult, law-abiding New York residents who both applied for unrestricted licenses to carry a handgun in public based on their generalized interest in self-defense.

The State denied both of their applications for unrestricted licenses, allegedly because Koch and Nash failed to satisfy the "proper cause" requirement. Petitioners then sued respondents—state officials who

oversee the processing of licensing applications—for declaratory and injunctive relief, alleging that respondents violated their Second and Fourteenth Amendment rights by denying their unrestricted-license applications for failure to demonstrate a unique need for self-defense.

The District Court dismissed petitioners' complaint and the Court of Appeals affirmed. Both courts relied on the Second Circuit's prior decision in Kachalsky v. County of Westchester, 701 F. 3d 81, which had

sustained New York's proper-cause standard, holding that the requirement was "substantially related to the achievement of an important governmental interest." Id., at 96.

Held: New York's proper-cause requirement violates the Fourteenth Amendment by preventing lawabiding citizens with ordinary self-defense needs from exercising their Second Amendment right to keep and bear arms in public for self-defense. Pp. 8–63.

(a) In District of Columbia v. Heller, 554 U. S. 570, and McDonald v. Chicago, 561 U. S. 742, the Court held that the Second and Fourteenth Amendments protect an individual right to keep and bear arms for self-defense. Under Heller, when the Second Amendment's plain text covers an individual's conduct, the Constitution presumptively protects that conduct, and to justify a firearm regulation the government must demonstrate that the regulation is consistent with the Nation's historical tradition of firearm regulation. Pp. 8–22.

To determine whether a firearm regulation is consistent with the Second Amendment, Heller and McDonald point toward at least two relevant metrics: first, whether modern and historical regulations impose a comparable burden on the right of armed self-defense, and second, whether that regulatory burden is comparably justified. Because "individual self-defense is 'the central component' of the Second Amendment right," these two metrics are "'central'" considerations when engaging in an analogical inquiry. McDonald, 561 U. S., at 767 (quoting Heller, 554 U. S., at 599).

To be clear, even if a modern-day regulation is not a dead ringer for historical precursors, it still may be analogous enough to pass constitutional muster. For example, courts can use analogies to "longstanding" "laws forbidding the carrying of firearms in sensitive places such as schools and government buildings" to determine whether modern regulations are constitutionally permissible. Id., at 626. That said, respondents' attempt to characterize New York's proper-cause requirement as a

"sensitive-place" law lacks merit because there is no historical basis for New York to effectively declare the island of Manhattan a "sensitive place" simply because it is crowded and protected generally by the New York City Police Department. Pp. 17–22.

Bruen holds that Charles County may NOT impose the restrictions you propose, specifically an ambiguous 100 yard zone around ALL buildings or property owned by Charles County Government or the Board of Charles County Commissioners without violating the Constitutional rights of all people in and around Charles County, or persons who may travel through the County.

Your organization has provided a 5 - page list of County owned property (attached) which would be affected by your bill. The Supreme Court has held that you (any government) may restrict arms in very few locations: forbidding their possession in sensitive places, such as schools and government buildings.

After *Bruen*, the constitutionality of gun laws will be based on whether the plain text of the Second Amendment protects the activities the laws are regulating. If it does, then "the government must affirmatively prove that its firearms regulation is part of the historical tradition" to set boundaries on gun use. Charles County has made no such attempt to justify your proposed restrictions.

Should your bill pass, you may expect a lawsuit from one (or several) civil rights organizations seeking a Temporary Restraining Order and a Permanent Injunction against the enforcement of the bill pending a full hearing. Your limited legal staff will be facing world class litigation experts and numerous binding precedent cases (Bruen, Heller, McDonald, Antonyuk, Koons v Reynolds, and Siegel v Platkin, etc). Should the County lose a civil rights lawsuit, YOU will be liable to pay the legal costs of the lawsuit against Charles County.

42 U.S.C. § 1988 authorizes courts to award reasonable attorney's fees to prevailing parties in civil rights litigation. This Court has recognized that the purpose of this statute is to ensure effective access to the judicial process for civil rights plaintiffs, and that fees may not be awarded to a prevailing defendant except where the plaintiff's action was frivolous, unreasonable, or without foundation.
