



## Commercial Hauler- Landfill Usage and Permits

The Charles County Landfill is open Monday - Saturday from 7:30 a.m. until 4:00 p.m. **After 3:30 p.m., no vehicles weighing over 10,000 lbs. will be weighed in.** All patrons must exit the landfill by 4 p.m. Failure to follow landfill times and rules can result in revocation of the permit and restricting access.

Please note that all commercial haulers must be registered and have a Landfill Usage Permit for each vehicle that will utilize the landfill. The Landfill Usage Permit is \$25.00 per vehicle and covers July 1 – June 30. Please include a check or money order with this application. If you would like to make this payment using a credit card, please ask a Scale House representative to process your credit card payment when you return this completed application.

Vehicles hauling garbage\* must be inspected by the Charles County Health Department to be certified to haul garbage within Charles County. The Health Department inspection is \$120.00. Payment is due at the time of inspection.

The Charles County Sanitary Landfill accepts waste only generated within Charles County. Any company found with waste generated outside of Charles County will be subject to violations and fines under the County code.

We encourage all commercial haulers to establish a Credit Account. If you are interested in applying for a Credit Account, please ask a Scale House representative for a Credit Account Application.

Please complete all pages of this application. Incomplete applications will not be processed. Registration is not complete until the \$25.00 per vehicle commercial permit fee is received.

*\*Garbage is defined as refuse, and any animal or vegetable matter from a kitchen, market, or store.*

**Basic Landfill Safety Rules for Waste Haulers, Subcontractors, and Customers:**

1. Charles County Government is **NOT** responsible for any vehicle damage or personal injury.
2. Personal Protective Equipment (PPE) must be worn, Hard Hats and Safety Vests are mandatory.
3. Drivers must be free of distraction.
4. Follow the directions of landfill personnel, observe all posted signs, traffic patterns and rules.
5. No loitering around the landfill. Stay with/in your vehicle.
6. Any threatening behavior will result in law enforcement involvement and can result in revocation of permit or restricted access.
7. Report unsafe or dangerous conditions to site management immediately.
8. All accidents and injuries, regardless of severity, must be reported to site management immediately.
9. All vehicles are subject to inspection.
10. The Landfill has the right to reject loads that contain hazardous, liquids, out-of-county waste, medical and special waste.
11. All vehicles, trailers, containers, and/or equipment must meet DOT requirements and must be fully covered and secured.
12. Roll-Off containers must be in good condition and with adequate chains to keep doors closed securely.
13. Drivers must open tailgates, remove tarps, and perform all work on the working face or, when available, use designated areas for tarping and cleaning.
14. All waste vehicles must be empty of all debris and close tailgates and doors securely before leaving the working face. Containers must be re-tarped.
15. Haulers must have tow hooks. Drivers must be able to hook and unhook the towing equipment to and from their equipment during inclement weather conditions. The driver must remain in the vehicle while being towed.
16. Haulers must follow all Charles County Government rules, as well local, state, and federal laws.
17. Do not leave any vehicles or equipment running unattended.

### **Commercial Vehicle Bulk Rates:**

Commercial vehicles classified by; Out of County ID, Vehicles with Trailers or a Hitch Attachment, Ladder Racks, Side Boards, Stake/Utility Body, Box Truck, Cargo Van, Signs, Logos/Lettering, Business Check or Credit Card

Bulk Waste - \$91 per ton/\$15 minimum

Bulk Waste w/ Mixed Recyclables - \$115 per ton/\$15 minimum

Roll-Off Container - \$115 per ton/\$15 minimum

Commercial Hauler Registration Fee \$25

Mattress/Box Spring - \$10 per each

### **Commercial Vehicle Recycling Bulk Rates:**

Scrap Metal - \$0 per ton

Yard Waste - \$50 per ton/\$15 minimum

Dump Trailers/Uniformed Crew/Loaded Lawn Equipment are considered commercial yard waste haulers.

### **Scrap Tire Rates:**

10+ Tires - \$225 per ton/\$15 minimum

Farm Tractor/Off Road - \$250 per ton/\$15 minimum

Car/Pick-Up Truck - \$2 per tire

Dump Truck/Tractor Trailer - \$25 per tire

Landfilled Tire Recovery Fee - \$40 per tire

*(Maryland law prohibits the landfilling of tires. Tires improperly disposed in the Charles County Landfill require staff to pause operations to remove the tires. Properly place tires in designated areas to avoid this fee.)*

*When hauling more than 5 tires you will need a Scrap Tire Haulers Permit. To receive a temporary waiver, please email Abigail.Pascual@maryland.gov, or contact the Maryland Department of the Environment at (410) 537-3315 or (800) 633-6101, extension 3315.*
