Charles County offers no regular aquatic programs for its residents. The High Schools allow the use of the pool, but the hours are restricted to the school year. Some Residential communities have pools, but access is limited to its residents and summer seasons.

Please provide a necessary and valuable aquatic center by reopening the CSM pool.
