
The purpose of hazard mitigation action items and associated projects is to reduce or eliminate long-term risk to people and property from hazards and their effects. In an effort to determine the status of the mitigation action items developed for the 2018-2023 Charles County Hazard Mitigation Plan, the Hazard Mitigation Planning Committee and representatives for the municipalities were asked to provide status updates. As a result, this mitigation status report was developed for this plan update. A progress status and additional details have been provided for each of the 2018 action items.

The table starting on page 3 lists the mitigation action items that were set forth in the 2018-2023 Charles County Hazard Mitigation Plan. The table provides the mitigation action item, community, hazard(s) addressed, lead agency or department and action status (Complete, Deferred, Canceled, Ongoing). In addition, status update details were provided in the "Status Update Notes" column. Action items ranked as a "High" priority in the 2018 Hazard Mitigation Plan are denoted with "High Priority."

A total of seventy (70) action items were evaluated as part of the plan update process; sixteen (16) of these action items were ranked as "high priority" in the previous plan. Members of the Hazard Mitigation Planning Committee (HMPC) provided important feedback regarding the progress of these action items. Based on this feedback, the following was determined: eight (8) mitigation actions are "completed," nine (9) mitigation action item was "deferred," and fifty (50) action items are "ongoing." No mitigation action items was canceled. The graph below further illustrates the present status of the 2018 mitigation actions based upon stakeholder feedback. (3 actions pending responses)



The mitigation actions identified as "completed" are listed below. Three (3) of the high priority mitigation actions was designated as "completed"; these mitigation actions are identified in red.

- Action Item #1 Install uninterruptible power supplies on critical electronic equipment in County facilities to prevent outages during thunder and lightning events.
- Action Item #6 Protect County buildings from hail damage by installing hail guards on roofmounted HVAC equipment and installing hail-resistant roofing and siding when feasible on newly constructed facilities.
- Action Item #12 Ensure that NFIP requirements are being met concerning repairs, renovations, and remodeling of structures located in the regulatory floodplain.
- Action Item #17 Identify roadways/bridges that frequently flood and mitigate to ensure ingress and egress.
- **Action Item #40** Continue inspection, maintenance, and enforcement program to help ensure continued structural integrity of dams.
- Action Item #41 Regulate development near steep slopes.
- Action Item #67 Create an Archaeological Context for Charles County based on a literature review of academic and historical works, and on information found in the archaeological data at the Maryland Historical Trust.
- Action Item #68 Prioritize list of critical facilities that are vulnerable to natural and humanmade hazards and develop potential mitigation solutions for high-priority critical facilities to reduce vulnerability.
