6. Public Hearing:

6.a Cannabis, ZTA #23-180

Staff introduced an Applicant's request for an extension of the approval for the Preliminary Subdivision Plan (PSP) for Potomac Chase, XPN-120003. Next, Staff made themselves available for questions of which there was none. There were no public comments.

A **MOTION** was made by Mr. Barnes to approve the extension as recommended by staff with the conditions noted in the staff report dated November 6, 2023, which was **SECONDED**, by Mr. Murray. The vote was unanimous, and the **MOTION** passed.
