- III. Old Business: No old business to discuss.
- IV. Approval of April 2023 Minutes: A motion was made by Secretary Saunders to accept the minutes from the April meeting; motion seconded by Vice President Brown; unanimously approved.
- V. Election Director's Report:
 - Director Dickerson informed the Board that the Charles County
