- II. Approval of August's Minutes: A motion was made by Member Norris to accept August's minutes; motion seconded by Member Gray; unanimously approved.
- III. Additions to the Agenda: No additional agenda items, agenda adopted as presented.
- IV. Election Director's Report: Director Dickerson explained to the group that the Drop Box Approval Plan was sent to the State Board of Elections (SBE) on 24 August, and that she is currently working on the Early Voting (EV) plan, then moving to Election Day (ED) polling place planning. Additionally, the Director announced:
 - All staff completed SBE-mandated Sexual Harassment Prevention training on 21 September.

Secretary Boston-Holland inquired what are the expectations for Board Member-conducted EV & ED polling place surveys, and Director Dickerson replied.
 - Deputy McDougal announced that her staff now has access to a new commercial folding machine, and voter registration cards are being printed & mailed to voters.
 Deputy McDougal also announced that ERIC reports are coming in to the office more

- frequently. In addition, Alex recently successfully completed SBE's Voter Registration 101. In response to an inquiry Deputy McDougal said that Absentee Registrations are around 8900 currently.
- Director Dickerson described a recent office visit from SBE's new Administrator Jared DeMarinis; it was a successful visit, complete with a staff photo!
- The Board inquired as to confidential status for themselves, the Director responded she will inquire with SBE and report back to the Board.
- V. Board Attorney Report: Sherri welcomed Karen Selby as the new Board attorney. Karen introduced herself, and contact information between Members was exchanged.
