The Board of Canvassers convened via video conferencing at 3:00 p.m. to review ballots that were referred from the canvassers.

Printing Canvass Results

After scanning all accepted vote by mail ballots, Mr. Richardson locked the ballot scanners and printed an Election Results Report. Ms. Dickerson confirmed that the number of accepted ballots equaled the number of ballots counted by the ballot scanners. Ms. Dickerson signed the Voting Results Report and attached it to the Zero Report. Ms. Dickerson stated that these results will be embargoed until after 8 pm on election day.
