- Ms. Dickerson discussed with the board that Karl A. Richardson II and Wade Beswick have completed signal testing for same day registration at all polling places except for Stethem due to renovations. We have scheduled to survey and signal test Stethem on Friday August 23rd.
- Mr. Richardson informed the board that signal testing went well at all polling places. Mr. Richardson explained that he was testing for wireless connection, which he received at every polling place. Mr. Richardson explained that when every county has finished signal testing SBE will distribute the final results.
- Ms. Dickerson explained to the board that she will be training all check-in judges and chief judges on SDR procedures for the upcoming Presidential Election.
- Ms. Dickerson explained to the board that a new law was passed giving voters the opportunity to drop off their absentee ballots at each polling place. There will be a bag similar to the provisional bag located at the chief judges table for those voters who drop off the absentee ballot on election day.

- Ms. Dickerson informed the board that a mock election is tentatively scheduled for November or December. This mock election is to test a new software version that SBE wants to implement for the upcoming election.
- Ms. Dickerson informed the board that the biennial conference will be held on October 17th at the Crowne Plaza Hotel. Located on 173 Jennifer Rd, Annapolis, MD 21401.
