Mr. Jake Dyer, Chief of Budget, Department of Fiscal and Administrative Services, explained that this transfer would cover the lowest bid received for the construction of this project. The Bryans Road Well Seven (7) project's construction bids are higher than the established budget but consistent with historical costs when inflated to today's dollars. The funds are available in the Water Contingency Fund.

Ms. Shanee Major-Kelly, Associate County Attorney I, Office of the County Attorney and Mr. Sam Drury, Chief of Recreation, Department of Recreation, Parks, and Tourism, reviewed the final lease for East Coast Hockey to lease space within the Capital Clubhouse to operate their business selling sports equipment/pro-shop for ice skating. East Coast Hockey is the current provider of team apparel for the Southern Maryland Sabres Hockey Club that operates out of the Capital Clubhouse. The lease has been drafted and reviewed by staff in County Administration and the County Attorney's office. Mr. Mike Hendrix, Owner of East Coast Hockey, has agreed to all the terms and signed the lease on July 15, 2019.

Commissioner Stewart questioned the language in Section Eight Point Two (8.2) related to multilevel parking.

A motion was made by Commissioner Rucci, seconded by Commissioner Stewart and passed, with all Commissioners present, voting in favor to approve the East Coast Hockey Lease while allowing the County Attorney the latitude to change the language in Section Eight Point Two (8.2) if he deems necessary.

Briefing and Request for Approval: Agricultural Deer Cooperator Permit (Limited Off-Season Deer Hunting) Letter of Support Request

Mr. Russell Shlagel, Property Owner, briefed the Commissioners on his request for a letter from the County Attorney to support and acknowledge his Agricultural Deer Cooperator Permit issued by the Maryland Department of Natural Resources (DNR) to conduct deer sharpshooting management on his farm. He reviewed the successful results of last year's operation. He acknowledged that the Charles County Sheriff's Office and the Department of Natural Resources were notified prior of each operation held during February and March of 2018. He mentioned that DNR had twenty-two tags and that his operation supplied half of the meat to Jude House and other nonprofits. He also acknowledged the positive meeting that Commissioner Stewart held prior to last year's operation.

Commissioner Stewart thanked Mr. Shlagel and informed him that she did not feel a public meeting was necessary this year.

Mr. Wes Adams acknowledged that Mr. Shlagel had completed all permits and qualifications for this year's permit. He also felt that providing notification before each operation was important.

A motion was made by Commissioner Stewart and seconded by Commissioner Bowling and passed, with all Commissioners present, voting in favor to approve the letter of support from the County Attorney with the added language to acknowledge that this was the second year of this type of operation and that the first year of this operation was successful.

Briefing and Request to Schedule a Public Hearing: Modification to the County's Fiscal Year 2019 MS4 Permit Financial Assurance Plan

Ms. Karen Wiggen, Planner III, and Mr. Charles Rice, Program Manager, Department of Planning and Growth Management provided the Commissioners an update on the Financial Assurance Plan Watershed Protection and Restoration Program. The purpose of this plan is to demonstrate the County's budget to implement the National Pollutant Discharge Elimination System (NPDES) Municipal Separate Storm Sewer System (MS4) permit's required twenty percent (20%) impervious surface restoration by December 2019. The County's current MS4 permit is being modified to add the Nutrient Trading option for this permit term ending December 2019. The estimated Nutrient Trading needed to comply with the MS4 permit is five hundred (500) acres. The next step would be to hold a public hearing to approve the new plan.

A motion was made by Commissioner Bowling, seconded by Commissioner Rucci and passed, with all Commissioners present voting in favor to schedule the public hearing on the Modification to the County's Fiscal Year 2019 MS4 Permit Financial Assurance Plan for October 8, 2019 at 6:00 p.m. in the Commissioners Meeting Room in the Charles County Government Building.

Public Hearing: Community Development Block Grant (CDBG) Program

The Commissioners conducted a public hearing on the proposed Bill 2019-02 legislative changes to Charles County Code Chapter 208 School Crossing Guards. Mr. Jerome Spencer, General Counsel, Charles County Sheriff's Office, reviewed the draft legislation which would amend the Charles County Code, Chapter 208 School Crossing Guards, to authorize the Sheriff to appoint school crossing guards if approved and budgeted by the County Commissioners.

There were no comments from the public.

A motion was made by Commissioner Bowling, seconded by Commissioner Rucci and passed, with Commissioners Bowling, Rucci, Stewart and Collins, voting in favor to close the record. *Commissioner Coates was not present for the vote.

A motion was made by Commissioner Bowling, seconded by Commissioner Stewart and passed, with Commissioners Bowling, Stewart, Rucci and Collins, voting in favor to close the public hearing. *Commissioner Coates was not present for the vote.

A motion was made by Commissioner Rucci, seconded by Commissioner Bowling and passed, with Commissioners Rucci, Bowling, Stewart and Collins, voting in favor to adopt Bill 2019-02, School Crossing Guards. *Commissioner Coates was not present for the vote.

<u>Public Hearing: Legislative Changes to Charles County Code Chapter 287 Vehicle Parking Laws, Bill 2019-03</u>

The Commissioners conducted a public hearing on the proposed Bill 2019-03 legislative changes to Charles County Code Chapter 287 Vehicle Parking restrictions. Mr. Jerome Spencer, General Counsel, Charles County Sheriff's Office, reviewed the draft legislation which would amend the Charles County Code to achieve consistency with language provided in the Annotated Code of Maryland.

There were no comments from the public. There was one (1) written comment.

A motion was made by Commissioner Bowling, seconded by Commissioner Stewart and passed, with Commissioners Bowling, Stewart, Rucci, and Collins, voting in favor to close the record. *Commissioner Coates was not present for the vote.

A motion was made by Commissioner Rucci, seconded by Commissioner Bowling and passed, with Commissioners Rucci, Bowling, Stewart and Collins, voting in favor to close the public hearing. *Commissioner Coates was not present for the vote.

A motion was made by Commissioner Bowling, seconded by Commissioner Stewart and passed, with Commissioners Bowling, Stewart, Rucci and Collins, voting in favor to adopt Bill 2019-03, Vehicles Parking Restrictions. *Commissioner Coates was not present for the vote.

Public Hearing: State Legislative Proposals

The Commissioners were joined by the Charles County Delegation to hear legislative proposals for the 2020 State Legislative Proposals. Commissioner Collins explained that no action would be taken tonight and that the follow up work session on these proposals would be held on September 24, 2019.

Charles County Sheriff's Office proposals:

- Medical Marijuana Use in a Correctional Facility. Amend Correctional Services Article §11-203 to prohibit medical marijuana in correctional facilities in Charles County.
- Service of Emergency Commitment Orders. Amend Health-General Article §10-623 to allow a court in Charles County to authorize law enforcement to enter a private home to serve a court-ordered commitment order.
- Transparency of Extreme Risk Protective Orders. Amend Public Safety Article §5-602 to limit confidentiality of extreme risk protective order proceedings to medical record otherwise protected by statute.

The Rural Planning and Zoning Task Force proposal:

 Amend Maryland Public Safety Code §12-508 (e) to allow Charles County to join ten (10) other Maryland counties and opt-in to legislation which allows certain agritourism buildings certain exemptions from building codes.

The Homeowners Association Dispute Resolution Board proposal:

 A proposal to amend §11B-104(c) of the Real Property Article, Annotated Code of Maryland to allow the HOADRB to enforce GOVERNING DOCUMENTS of the HOA, instead of "recorded covenants of restrictions"...

The Southern Maryland Carousel Group proposals:

- Legislative request for no match grant of three hundred thousand dollars (\$300,000) to fund Southern Maryland Carousel and wood carving center.
- Amendment to Authorizing act to extend the termination date of the existing grant in the amount of twenty-five thousand dollars (\$25,000), originally approved in 2012 and known as GO62.

The Southern Maryland Association of Realtors proposal:

 A proposal to re-introduce H.B. 1051 - Charles County - Landlord and Tenant - Repossession for Failure to Pay Rent - Procedures, introduced by Del. Wilson in 2019 Session of Maryland General Assembly.

Citizen Proposals:

Mr. Michael Runfola proposal:

• A proposal to provide broadband to all parts of Charles County not currently serviced, funded by legislation that will allow slot machines over the water of the Potomac River.

Ms. Bonnie Rothell proposal:

• A proposal to amend Alcoholic Beverage Article, § 2-216 Ann. Code of Maryland to allow owners of small family farm wineries to also have an ownership interest in a small family-owned business establishment that sells alcohol.
