### Charles County Health Department Update: Coronavirus/COVid-19

Dr. Dianna Abney, Health Officer, Charles County Department of Health; Ms. Michelle Lilly, Director, Department of Emergency Services provided an update on COVID-19 statistics. Ms. Lilly reviewed the weekly statistics and noted the decline of the positivity rate and overall statistics. She also noted that the County's COVID positive number of two-point eight four percent (2.84%) was lower than the States COVID positive number of three-point zero nine percent (3.09%). Dr. Abney reviewed COVID Testing and the need to adhere with social distancing, wearing masks, washing hands, and not gathering in large groups. Dr. Abney stated that Contact Tracing is still occurring and encouraged anyone who test positive be forthcoming with the information requested and the people you have been in contact with. She stated that the Department of Health is following the Centers for Disease Control (CDC) and Prevention guidance during the holiday season, including wearing masks, avoiding high-risk activities and large crowds, and practicing social distancing.

They further outlined the membership of this board as well as the many committees that they serve on. Over twenty-one thousand nine hundred and sixty-eight (21,968) families have been served.

### Discussion: Charles County Sheriff's Office Essential Duty Pay

Lt. Col. David Saunders and Ms. Erin Shoemaker, Deputy Director of Budgeting, Charles County Sheriff's Office, discussed their essential duty pay for their police officers, correctional officers, and front-facing civilian employees. The Sheriff's Office requested to transfer three hundred forty-one thousand dollars (\$341,000) which would allow the Sheriff's payroll office to properly input hours into the payroll system for COVID-19 shift response pay from September 12, 2020 through October 9, 2020.

A motion was made by Commissioner Rucci, seconded by Commissioner Bowling and passed, with all Commissioners present, voting in favor to approve the request to correct the accounting code.

A motion was made by Commissioner Bowling, seconded by Commissioner Rucci and passed, with Commissioners Bowling, Rucci, Coates, and Collins present, voting in favor postpone/table the funding request to provide additional incentive pay of three dollars and thirteen cents (\$3.13) for each hour worked to qualifying personnel from October 24, 2020 through December 31, 2020.

Commissioner Stewart was opposed. A roll call of the vote was taken: Commissioner Rucci-yes; Commissioner Bowling-yes; Commissioner Stewart-no; Commissioner Coates-yes; Commissioner Collins-yes. The motion passed four (4) to one (1).

Commissioner Bowling also requested that staff bring back potential cost for all Charles County frontline personnel.

### **Discussion: Body Worn Camera Program**

Ms. Tracy Dickerson, Election Director; Ms. Katie O'Malley-Simpson, Chair, and other members of the Board of Supervisors for the Board of Election, provided an update on the 2020 Election. They provided an overview of mailed out ballots, registered voters, drop box locations, deadlines, early voting center and voting center locations and times as well as the link for viewing the virtual count of ballots.

### Commissioners' New Business

Commissioner Collins informed the Commissioners that the Charles County Delegation was holding a virtual public hearing to listen to proposed Bond Initiatives on Monday October 26, 2020. He also mentioned that on the Commissioners' October 27, 2020 agenda, there will be an opportunity for the Commissioners to present any Bond Initiative proposals for discussion and with Board approval they will be submitted to the Charles County State Delegation for consideration for 2021.
