Mr. Wes Adams, County Attorney, reviewed Governor Hogan's new orders for allowing reopening of certain businesses and facilities subject to local regulation and the interpretive guide.

Ms. Lilly reviewed Charles County statistics indicating an increase in COVID positive numbers. Dr Abney reviewed her recommendations which included prohibiting more than one hundred (100) persons at outdoor gatherings and mandating limiting indoor gatherings to twenty-five (25) people or less.
