Commissioner Collins also informed the Commissioners that a letter of support was sent to support Howard County's Economic Development Authority's proposal for the Maryland Cyber Workforce Solutions being sent for the U.S. Economic Development Administration's Build Back Better competitive grant.

## Charles County Health Department Update: Coronavirus/COVID-19

Dr. Dianna Abney, Health Officer, Charles County Department of Health; Ms. Michelle Lilly, Director, Department of Emergency Services; and Mr. William Grimes, Vice President, Ancillary Services & Incident Commander, UM Charles Regional Medical Center, provided an update on COVID-19 statistics and how they are responding to COVID-19.

Dr. Abney reviewed the continuation of indoor mask mandate to help prevent the spread of respiratory illness and as a key strategy to prevent the spread of COVID-19. She indicated that the positive case rate in Charles County is on a downward trend, which she believes is due to the mask mandate. She reviewed the case rates and percentages of positivity and overview of COVID-19 cases. She shared the statistics on Charles County cases and hospitalizations by age. She provided an overview of COVID-19 deaths by gender and age. She also reviewed the post vaccination infection data. She provided information on the booster shots by Moderna, Pfizer and Johnson & Johnson. She indicated that a

vaccine for children should be released soon. She concluded her presentation with safety tips for Halloween 2021.

Ms. Lilly reported on the COVID positive EMS Transports per month in 2021 and as of this date there were twelve (12) transports at this time for October. She informed the Commissioners that the Department of Emergency Services (DES) will continue to monitor COVID and provide support as needed,

Mr. Grimes noted that there were eight (8) COVID deaths in the hospital. He also indicated that staffing is tight as in all areas.

Ms. Jennifer Harris, Chief of Media Services, Office of the County Administrator, reiterated media's support for the Health Department efforts and the ongoing media support related to the importance and availability of COVID-19 vaccinations. She indicated that the communications efforts are focused on informing residents about the importance and availability of COVID-19 vaccinations, as well as misinformation that is being put out on social media and discussions media specialists have been having to combat this issue. She informed the Commissioners of the newest podeast featuring Dr. Navarro, Superintendent, Charles County Public Schools.

Mr. Jason Stoddard, Director of Safety, Charles County Public Schools, joined the discussion and provided an update on the schools cases of COVID -19 positive and contact tracing efforts and case statistics. He indicated that there has been a decrease over the last three (3) weeks. He talked about the expansion of the schools extra screening process being used.
