Ms. Jenifer Ellin, Director, and Mr. Jacob Dyer, Chief of Budget, Department of Fiscal and Administrative Services, provided a presentation on the Fiscal Year 2022 Second Quarter General Fund Review. They reviewed revenues and expenditures and compared the second quarter numbers to the September 2021 update. The County is expected to end this fiscal year with a surplus of almost fourteen (\$14) million dollars mainly due to receipt of one-time revenues. The recommended uses include Circuit Court Elevators, White Plains and Laurel Springs Turf projects, and Popes Creek Feasibility Study in the Capital Improvement Project (CIP) Pay Go Fund Balance.

Briefing: Update on American Rescue Plan Act (ARPA)

Ms. Jenifer Ellin, Director and Jacob Dyer, Chief of Budget, Department of Fiscal & Administrative Services, provided an update on the American Rescue Plan Act. The County received thirty-one million seven hundred and ten thousand seven hundred and fifty-eight dollars (\$31,710,758.00) for Coronavirus Local Recovery Funds which have been used to support local businesses and non-profits, public safety, infrastructure, administration, and public health.

Discussion: Town of La Plata Water Appropriation

Town of La Plata -Mayor Jeannine James; Town Council, Mr. James Goldsmith, Ms. Evalyne Bryant-Ward, Mr. Matthew Trollinger, Mr. David Jenkins; and Mr. Bobby Stahl, Director of Operations, Mr. Brent Manuel, Town Manager, Mr. Kevin Greenville, Town Treasurer and Ms. Michelle Miner, Assistant Town Manager, and Ms. Deborah Carpenter, Director, Mr. Jason Groth, Deputy Director, and Ms. Alicia Afroilan, Engineering Supervisor, Department of Planning and Growth Management; Ms. Jenifer Ellin, Director, and Mr. Jacob Dyer, Chief of Budget, Department of Fiscal and Administrative Services; and Mr. Wilson Cochran, Acting Director, and Mr. John Stevens, Chief of Capital Projects, Department of Public Works, joined the Commissioners to discuss the Town of La Plata water appropriation request. Mr. Groth provided an overview and history of current and future water resources and possible framework for establishing a water-supply agreement with the Town.
