Ms. Mitchell provided an update on the following legislation in the 2022 Maryland General Assembly Session:

## HB1428 Code Counties - Legislative Procedure - Notice Requirements

Hearing scheduled for March 11, 2022. Ms. Jenifer Harris, Chief of Media Services, will provide oral testimony.

HB1416 Charles County - Property Tax - Credit for Volunteer Emergency Responders Hearing scheduled for March 15, 2022.

The Commissioners reached a consensus to send a letter of support.

HB1423/SB865 Charles County - Alcoholic Beverages - Multiple Class B Licenses Awaiting Hearing Date.

HB739/SB916 Workgroup to Study the Fiscal and Operational Viability of Public-Private Partnerships for Charles County Public Schools

The Architect Association proposed an amendment to include an architect as a member type to this work group.

The Commissioners reached a consensus to send a letter of support as Bill is written.

HB1415 Grading and Sediment Control Plans - Agricultural Land Management Practices - Definition Hearing scheduled for March 11, 2022.

The Commissioners reached a consensus to send a letter of support.

## HB514/SB388 Charles County - Natural Resources - Sunday Hunting

Hearing scheduled on March 9, 2022. The Commissioners submitted letter of support and Commissioner Bowling will provide oral testimony.

## HB1187/SB726 Transportation - Highway User Revenues - Revenue and Distribution

Maryland Association of Counties (MACo) supports this Bill. The Commissioners submitted letter of support and Commissioner Collins provided oral testimony.

HB1124 Primary and Secondary Education - Local School Systems - Budget Reporting The Commissioners submitted letter of support.

HB1290 Education - Public School Construction - Funding and Administration The Commissioners submitted letter of support.

#### HB162 Public Safety - Law Enforcement - Body-Worn Cameras

The Commissioners submitted letter of support with MACo amendments.

## SB297 Gaming - Sports Wagering Facilities - Locations

Prohibiting the Sports Wagering Application Review Commission from awarding a sport wagering license to a facility located within a 10-mile radius of certain designated Class B-1 or B-2 sports wagering facilities located in Calvert, Carroll, Charles, Frederick, and Washington counties.

Senator Elis requested a letter of support.

The Commissioners discussed how this would limit Economic Development in Charles County.

A motion was made by Commissioner Stewart, seconded by Commissioner Bowling and passed, with all Commissioners present, voting in favor to send a letter of opposition describing the economic development concerns with the restrictive radius in Charles County.

## **Briefing: Food Security and Food Resilience**

Ms. Lindsay Smith, Regional Food Systems Planner, Metropolitan Washington Council of Governments (COG); Mr. Mark Scott, Critical Infrastructure Specialist, DC Department of Homeland Security and Emergency Management; and Ms. Anne Wallerstedt, Senior Director Government Relations, Maryland Food Bank, provided a presentation on food security and food resilience. Highlights included the impact of COVID-19 pandemic on food security, the response to food insecurity, Maryland Food Bank's impact, the COG FARM priorities, and planning for food and water resilience.

A motion was made by Commissioner Bowling, seconded by Commissioner Rucci and passed, with all Commissioners present, voting in favor for Charles County to establish a food security and resilience workgroup in Charles County.

This motion was clarified that staff would bring back an assessment to evaluate the process in Charles County before establishing a work group and would also provide recommendations to the Commissioners.

## Briefing and Request for Approval: Transit Division Annual Transportation Plan (ATP)

Ms. Deborah Carpenter, Director, and Mr. Jeffry Barnett, Chief of Transit, Department of Planning and Growth Management, provided a presentation overview of the Annual VanGO Transportation Plan. This is the grant application to the Maryland Department of Transportation Transit Administration for transit operating and capital assistance. Mr. Barnett reviewed the current status, application highlights, and request to approve the authorizing resolution needed for the application.

A motion was made by Commissioner Coates, seconded by Commissioner Bowling and passed, with all Commissioners present, voting in favor to approve Resolution 2022-02 authorizing Charles County to file an application with the Maryland Transit Administration of the Maryland Department of Transportation for one or more grants under the Federal Transit Act.

## Update: Board of Election Procedures and Election Information

Ms. Tracy Dickerson, Election Director, Charles County Board of Elections, provided an update on the board's election procedures and information. The board consolidated polling locations within the County. Polling locations available for the upcoming election will include C. Paul Barnhart Elementary School, Matthew Henson Middle School, La Plata High School, Mattawoman Middle School,

McDonough High School, Samuel A. Mudd Elementary School, North Point High School, Milton M. Somers Middle School, St. Charles High School, Thomas Stone High School, and William B. Wade Elementary. Early voting centers will include Waldorf Jaycees, Sacred Heart Church Friendship Hall, and St. Joseph's Parish Center. Early voting centers are at the Waldorf Jaycees; St. Joseph Church in Pomfret; and Sacred Heart Church in La Plata. There will be six (6) drop box locations, Waldorf Jaycees, St. Joseph Church, Westlake High School, Lackey high School, Thomas Stone High School and at the Election Center Office.

## Briefing: College of Southern Maryland State of the College

Dr. Maureen Murphy, President, Mr. Jose Gonzalez, Trustee, and Board of Trustees Members, College of Southern Maryland, provided a video presentation on the State of the College, including the economic value of the college and economic impact and investment analysis. Dr. Murphy recognized the County Commissioners with a certificate of appreciation for providing Charles County Care scholarships, which have provided educational opportunities for students.

# Briefing: Tri-County Council for Southern Maryland (TCCSMD) Summer Youth Employment Program

Ms. Ruthy Davis, Director, Reginal Workforce & Business Development, and Mr. Greg Holtz, Youth Program Manager, Tri-County Council for Southern Maryland (TCCSMD), provided a PowerPoint presentation overview on the 2022 Summer Youth Program. This is a six (6) week paid employment and training program. The program offers County youth with the opportunity to develop skills, set career goals, and learn more about their community. They reviewed the benefits of the program, who they served, benefits, and costs. Student testimonies were shared along with a video from a student about the program.
