A motion was made by Commissioner Bowling, seconded by Commissioner Stewart and passed, with Commissioners Bowling, Stewart, Rucci, and Collins present, voting in favor to schedule the public hearing on October 19, 2022 at 6:00 p.m. using a hybrid format in the Government Building Conference Room. Commissioner Coates was opposed.
