<u>Annual Maryland Department of Transportation (MDOT) Consolidated Transportation</u> <u>Program (CTP) Tour</u>

Mr. Sean Powell, Deputy Secretary Maryland Department Transportation and other State of Maryland transportation officials met with the Commissioners in person as part of the State's Annual Transportation Tour to brief local jurisdictions on the state of Maryland's transportation program (CTP), and capital budget. Members of the Charles County State Delegation, Delegates Patterson, Wilson, Davis, and Senators Ellis and Jackson joined the meeting as well. Participants discussed MDOT's Draft FY2023- FY2028 Consolidated Transportation Program, which details a nineteen point nine (\$19.9) billion dollars six-year capital budget investment in the state's transportation network. The meeting is part of MDOT's tour of twenty-three (23) Maryland counties and Baltimore City to update local officials and the public on the CTP. Deputy Secretary Powell and other MDOT officials outlined the state's investments and discuss Charles County's transportation priorities.

for amendments to the Comprehensive Water and Sewer Plan are reviewed on a semi-annual basis, with application deadlines in February and August. The Department of Planning & Growth Management received one (1) application for amendments prior to the February 2022 deadline. The application was a request from Whitman, Requardt and Associates, LLP on behalf of St. Charles Community, LLC regarding the to be-developed Horizon neighborhood in St. Charles. The application request changes to the sewer and water categories for the subject parcel along the north side of MD 488 (La Plata Rd) and the requested changes are from water categories W-5 to W-3DEV and from sewer categories S-5 to S-3DEV. Staff recommended the proposed changes.

Ms. Elizabeth Theobalds, Deputy County Attorney, Office of Charles County Attorney; and Ms. Jenifer Ellin, Director, Department of Fiscal and Administrative Services, explained that the proposed legislation will amend Chapter 54-9(G) of the Charles County Code to clarify the benefit eligibility for surviving spouses. The purpose of the amendment is to include the minimum age requirement of the volunteer, as specified in other provisions of the LOSAP benefit chapter.
