<u>Public Hearing: Bill 2022-14 Weapons and Firearms Prohibited on County-Owned or Operated Property</u>

The Commissioners conducted a hybrid (virtual/in person) public hearing on proposed Bill 2022-14 Weapons and Firearms Prohibited on County-Owned or Operated Property. Commissioner Collins read the public hearing statement and outlined the process for hearing the in-person comments first then the virtual comment.

Ms. Danielle Mitchell, Associate County Attorney II, Office of County Attorney for Charles County joined the Commissioners to review the proposed Bill 2022-14 with the approved amendments. She explained that this Bill would not have anything to do with Charles County Public Schools property or policies, Specifically Government owned and operated properties. She also indicated that Recreation, Parks, and Tourism staff requested a follow up work session after this public hearing since so that the County's current Standard Operating Procedures policy can be reviewed and changed since some of the language in Bill can be confusing.

A motion was made by Commissioner Bowling Seconded by Commissioner Stewart and passed, with all Commissioners present, voting in favor to approve including retired officers and clarifying language related to Charles county Public Schools into this Bill.

The Commissioners heard testimony from nine (9) of the fifty (52) citizens registered to provide inperson comments.
