Next Scheduled Commissioner Session(s): February 14-15, 2023

Update: Health of the County

Dr. Dianna Abney, Health Officer, Charles County Department of Health, provided an update on infectious diseases in Charles County. Charles County has a twelve point five five (12.55) percent positivity rate for COVID-19; a case rate of eleven point two nine (11.29) per one hundred thousand (100,000) and is still in the low COVID-19 community level. In Charles County, seventy four (74) percent of residents have been fully vaccinated against COVID-19. Dr. Abney explained that the Biden administration plans to end the COVID-19 national emergency on May 11, 2023. This means coverage for COVID-19 will become more like coverage for other medical conditions. This does not mean that that the virus has been eradicated. CDC still advises everyone to get vaccinated and latest booster, use at home tests and stay home if sick, and wear a high quality mask when COVID-19 levels are high. Dr. Abney's report on the flu indicated that overall respiratory illnesses Maryland is minimal with a four point six (4.6) percent positivity rate. Dr. Abney indicated that she would try to give monthly updates.

Briefing: 2023-2026 Local Management Board Community Plan

Ms. Laura Gustafson, Local Management Board Coordinator, Ms. Sapreen Khalaifeh, Local Management Board Specialist, and Ms. Dina Barclay, Director, Department of Community Services, provided a presentation on the 2023-2026 Local Management Board Community Plan. The Charles County Advocacy Council for Children, Youth, and Families is an active part of twenty (20) external community initiatives that serve children and families in Charles County and directly funds eight (8) programs. The community plan captures a snapshot of their current and future efforts.

Briefing: FY2023 General Fund Review-Second Quarter

Ms. Jenifer Ellin, Director, Mr. Jacob Dyer, Chief of Budget, and Ms. TaTanya Bowman, Assistant Chief of Budget Department of Fiscal and Administrative Services, provided a presentation on the FY2023 General Fund Review for the Second Quarter. Highlights included additional details on property taxes, income taxes, expenditures, and the fund balance budget. The FY2023 Adjusted Budget includes thirty four (34) million dollars of fund balance use. Due to favorable revenues, it is projected that twenty eight point three (28.3) million dollars will be needed to offset the estimated net operating loss.

Commissioner Bowling questioned if LGIT would cover civil lawsuit costs for discrimination for current situation.

Wes explained that civil lawsuit is covered by the County; LEGIT covers Tort, contractual not covered by LEGIT.

Briefing: Update on American Rescue Plan Act (ARPA)

Ms. Jenifer Ellin, Director and Jacob Dyer, Chief of Budget, Department of Fiscal & Administrative Services, provided an update on the American Rescue Plan Act. These funds support local businesses and non-profits, public safety, infrastructure, and public health. A new webpage was developed to provide additional detail on how ARPA funds are being spent.

Commissioner Collins discussed national the affordable housing project assessment and would like to consider the use of funds not used for affordable housing.

Commissioner's New Business

Commissioner Bowling read the following email received from Mr. Wes Adams, County Attorney, Office of County Attorney for Charles County:

"Dear Ms. Tadros and Commissioner Coates:

I am in receipt today of a one page notice of interlocutory appeal regarding the TRO entered by Judge Green. I am writing to inform you that the BOCC authorized the County Attorney's Office to pay for costs related to the Circuit Court proceedings to determine the narrow question of whether the Board's June 9, 2020 action survives into the new term and is binding on the commissioners. The BOCC did not authorize any member to appeal the decision and thus, did not authorize the expenditure of county funds on behalf of any appeal. In fact, Commissioner President Collins expressly raised the fact to Commissioner Bowling that he did not want the matter appealed (to prevent "dragging this matter out") which request was agreed to by Commissioner Bowling. Therefore, in my opinion, the Board implicitly rejected any authorization to expend county funds for any appeal of the circuit court's decision when it authorized this declaratory judgement suit. The explicit rules of engagement were for a circuit court proceeding - hence my language in the authorization letter I provided below that this was "a limited representation".

Therefore, while Commissioner Coates is certainly free to pursue an interlocutory appeal of the Circuit Court's TRO, the County will not pay for that expense, and you can direct any invoice for those services directly to Commissioner Coates, unless and until the full Board of County Commissioners authorizes that expenditure.

Thank you, Wes Adams"

Commissioner Collins questioned why this was being brought up, since personnel matters or litigation is closed session.

Commissioner Bowling indicated that he was trying to find out if Commissioner Coates was seeking funding from the County for an appeal.

Commissioner Stewart clarified that this was not covered under the Open Meetings Act for closed session since it did not discuss legal strategies, it is only about funding.

Mr. Adams, clarified that this item should not be discussed now and that he sent it to Commissioner Collins as well for the decision to add to an agenda.

Commissioner Stewart asked for clarification if a budget request is an open session discussion. Mr. Adams indicated that it would be an open session discussion.

Commissioner Stewart then went on to ask if the email from the County Administrator related to Commissioner Collins account was an open or closed session item. Mr. Adams indicated that it was a closed session discussion under personnel.

Commissioner Stewart that both these items be discussed at the agenda meeting tomorrow. It was clarified that the Commissioner scheduled to join the agenda meeting with Commissioner Collins was Commissioner Stewart and the meeting will be held tomorrow (Wednesday February 8, 2023 at 8:00 a.m.)

Commissioner Bowling indicated that he heard Commissioner Coates say that they would no longer be attending any agenda meetings. Commissioner Collins clarified that there has not been a change in the process that he is aware of, and that there was no change.

At 4:05 p.m., a motion was made by Commissioner Stewart, seconded by Commissioner Bowling and passed, with all Commissioners present, voting in favor to adjourn.
