Discussion: Aquatics Use of College of Southern Maryland (CSM) Pool

Ms. Kelli Beavers, Director, and Mr. Sam Drury, Deputy Director, Department of Recreation, Parks, and Tourism, provided a presentation of aquatic services in Charles County and the use of the College of Southern Maryland's (CSM) swimming pool at the La Plata campus. Ms. Beavers and Mr. Drury provided an overview of current aquatics facilities in Charles County, an assessment of future aquatics needs, and the costs associated with renovating and operating CSM's swimming pool. The proposed use does not meet the community's needs and the cost does not fit within the current Capital Improvement Program (CIP) budget. They proposed that the Commissioners consider during the FY25-FY29 CIP budget process for funding to be moved up to construct a multi-generational recreation facility that includes aquatics, with initial funding to be allocated in fiscal year 2025.

The Commissioners reached a consensus to follow staff's recommendations to move up this funding in the CIP and not repair the CSM pool. The Commissioners also directed staff to prepare a detailed letter to the state delegation outlining the challenges associated with renovating and operating the CSM pool, and stating a preference for using bond funding for construction of a multi-generational recreational facility that includes aquatics into the project. This letter should be brought back for approval on December 12, 2023.

If there is a unanimous vote to remove by all the Commissioners who are not subject to the finding of workplace misconduct, it shall take effect immediately and be followed by the appointment by the Governor to fill the vacancy according to the local government article of the annotated code of Maryland.

There were no twelve (12) in person public comments provided and five virtual public comments provided.

Commissioner Collins read the following statement:

"The legislation in question was originally proposed as a mechanism to create a process to recall a sitting Commissioner. We learned through the thorough research of our legal staff that we couldn't do that. The present Bill is flawed. There is not an example of any county government that has in place similar legislation. There is certainly not an example of Code Home Rule for of government that has in place similar legislation. Flawed legislation is never a sound option. I've maintained an open mind in considering this bill. My conclusion is that it would create bad precedent by moving forward with this Bill. There are processes in place to remove an elected official that has been determined to have violated the law. The people therefore are not without options."

A motion was made by Commissioner Bowling, seconded by Commissioner Stewart and passed, with Commissioners Bowling, Stewart, and Patterson present, voting in favor to keep the public record open for ninety (90) days. *Commissioner Collins was opposed. A roll call of the vote was taken: Commissioner Bowling-yes; Commissioner Stewart-yes; Commissioner Patterson-yes; Commissioner Collins-no. The motion passed three (3) to one (1). *Commissioner Coates was not present for the vote.
