Briefing: 2026 Capital Improvement Program (CIP) Report-Waldorf Urban Park and Amphitheater

Mr. Jacob Dyer, Acting Director, Department of Fiscal and Administrative Services; Ms. Kelli Beavers, Director, and Mr. Sam Drury, Deputy Direct, Department of Precreation, Parks, and Tourism; and Ms. Jenifer Ellin, Acting Deputy County Administrator, Office of the County Administrator, provided a status on the State funding, through the Maryland Bond Bill in 2022, which was given to support a Waldorf Urban Park and Amphitheater project. Currently this project is not included in the County's Capital Improvement Projects(CIP) FY2024-FY2028 and would need to be amended to add it

to use this grant. Staff recommendations were to complete a feasibility study; once the study is completed, consider adding this project to the CIP; and work with the Charles County Delegation to repurpose or utilize the available funding.

The Commissioners present reached a consensus to have staff complete the feasibility study and provide the Commissioners with an update on the results.

Briefing: FY2024 First Quarter General Fund Review

Mr. Jacob Dyer, Acting Director, and Ms. TaTanya Bowman, Assistant Chief of Budget Department of Fiscal and Administrative Services, presented the FY2024 General Fund Report for the First Quarter ending September 30, 2023. The FY2024 Adjusted Budget includes a twenty-nine point five (\$29.5) million dollar of fund balance use. Due to favorable revenues, it is projected that twenty-six point seven (\$26.7) million will be needed to offset the estimated net operating loss. Mr. Dyer shared his concerns that the income tax returns are down statewide and for Charles County it is down four percent (4%) which could have an impact on the FY2025 budget.

Briefing and Request for Approval: Update on American Rescue Plan Act (ARPA)

Mr. Jacob Dyer, Acting Director, Department of Fiscal & Administrative Services; and Ms. Jenifer Ellin, Acting Deputy County Administrator, Office of the County Administrator, provided a status update on the County's American Rescue Plan Act (ARPA) funding.

A motion was made by Commissioner Bowling, seconded by Commissioner Patterson and passed, with Commissioners Bowling, Stewart, Patterson and Collins present, voting in favor to approve transferring eight hundred and sixteen thousand nine hundred and fifty two dollars (\$816,952.00) from the Health Department ARPA accounts to the Department of Emergency Services to implement a Behavioral Health Crisis Response project to include the approval of eight (8) Personal Identification numbers (PINS) for four (4) Paramedics and four (4) Emergency Services Technicians. *Commissioner Coates was not present for the vote.
