Please find my additions thus far, I based my addition (in blue) off of the additions from Dr. Karla Kornegay.

Council members shall be elected alternative years of the General Assembly and not be family members, close friends, CEOs or Board members of non-profit organizations (especially in the County), County Stakeholders in any capacity, former elected officials, acquaintances and/or any individuals who have received funds from the county for business related activities and/or non-profit organizational activities, nor individuals who may have For Profit businesses in Charles County or benefit from doing business in Charles County as a Prime Contractor or a SubContractor, or have an immediate family member who has a business in Charles County or benefits from a business in Charles County either by way of direct funding from the Charles County Government, State Government in regards to Charles County or Federal Government in regards to Charles County or any military institution, quasi government entity in Charles County. Individual Council Members shall not be employees of any County (particularly Charles County), Maryland State or Federal employees, Active Military benefitting from the realignment or increased funding to any military base located in Charles County either directly or any other vehicle (including but not limited to another contractor, subcontractor, nonprofit, lobbying firm. etc). Names of qualified members will be promptly selected by a special election or drawing qualified names out of a "hat" of sorts. Anyone in an elected position can't have a role in the process. No one individual name will be eliminated based on how current elected officials feel about said individual. Any potential councilmember must not have a criminal background, felonies, misdemeanors of any kind, they must not be in financial distress, nor currently in bankrupcty or arrears in taxes, irregardless of being in a payment plan, and/or have any outstanding monies to the Charles County Government, Maryland State Government, or Federal Government in excess of \$100 for any reason at any time before or during holding office, they must complete and financial disclosure form, they must not have any financial dealings with the County or be stakeholders with entities that are stakeholders in the County or have financial dealings with the County. They must disclose all business relationships of any kind including but not limited to silent partnerships in for profit or nonprofit entities, government contracts as a prime or subcontractor.

(e) Change to read, "All local elections should be held at a different time from state elections"

## 205 Qualifications

(a) suggestion was to change the number of years each Council member needed to be a

registered voter and live in the County. It currently reads one year. We discussed the fact that it should be longer but never came to a consensus.

#### 206 Term of Office

(d) there is confusion about absences....while it speaks to how many absences a member shall not have...it does not specify what the sequence will be.

# 207 Compensation

What are 5 councilmen going to be doing full time? The average salary for councilmen/women in the National Capital Region (DC, MD, VA locale) is between \$29,625 to \$38,265 per year.

# 208 Forfeiture of Office

(2) at the end of that sentence, after moral turpitude...add ethics violations, sexual harassment, discrimination, retaliation, discriminatory harassment, libel, slander, innuendo or any violation of the Charles County Standard of Conduct, the MD Constitution and any federal, state or local laws.

## OR

the Council member being convicted of or pleading guilty to a felony or a crime involving moral turpitude, racial discrimination of any race people by any race of people, color, sex, (including pregnacy, sexual orientation and gender identity), disability, genetic information, ethnicity, discriminatory harassment, slander, libel, innuendo, retaliation, sexual harassment, hostile work environment and/or any violation of ethics as defined by Federal and State law and the current (as of 2023-2024) county policies.
