Good Morning Ms. Elkins,

My apologies.

Please see my testimony below:

We keep hearing from certain people that Home Rule should stay because a Charter Form of government would be corrupt, bring more crime, raise taxes, or simulate as Commissioner Bowling has stated without any public apology....fascism.

Well let's look at what happen or is happening under Home Rule

- 1) CCPS, CCSO, CC State's Attorney's Office, The Courts, or any other government agency or organization has never sought a decrease from the previous years' budget. In fact, the FY25 Operating Budget is approximately \$561,000,000 operating budget is the highest in Charles County History with a 6.4% increase from FY24
- 2) During the Murphy Administration, Commissioners Robinson, Stewart, and Murphy voted in favor of the following despite strong public opposition, no verifiable quantitative data, or public hearings while Commissioners Davis and Rucci voted the opposite and/or abstained

- a. Passed the Watershed Conservation District, which robbed Western Charles County property owners of their true property values
 - b. Took away actual true ownership of their land
- c. Gave land intended for economic development and owned by the taxpayers to conservation groups whom some, didn't reside in Charles County
- d. Spent approximately \$4.3 million taxpayer dollars to buy a building (in secret) and cited for violating the State Open Meetings Act.
- e. Voted (in secret) to pay legal bills for a criminal vs civil offense for two former County officials, one being former Commissioner President Candice Kelly between December 2015 and February 2016.
- f. Sued two citizens for daring to expose the payments through a public information act request and lost.
- g. Commissioner Stewart was able to attend meetings twice a month, often in closed session thanks to former Commissioner President Murphy changing meeting schedule to accommodate her *then* Prince George's County teaching schedule
 - h. Replaced plastic straws for paper straws
 - i. Raised property tax rate
 - j. Approved County Commissioners' pay raise
 - k. Passed several anti-business policies
- l. But not be forgotten, Commissioner Bowling still refuses to discuss/invite any voting charter board member to his town halls and continues to spread disinformation on social media and scheduling meetings on the same day as the Charter Board (next meeting May 23rd)

- m. Added bonus...current Home Rule Hierarchy of Power within our Government...County Administrator, Commissioners, then the People...with the Charter...The People will always be first!
- 3) I am requesting responses to the following questions from Commissioners Bowling and Stewart:
 - a. How many Charter Board meetings have you been to?
- b. How many times have you invited the Charter Board to your town halls?
 - c. How many Charter Board public forums have you intended?
- d. Have you provided the resources, or has the Acting County Administrator provided the necessary resources to educate residents? This doesn't include news articles but rather factual resources to research for themselves?
- e. Do you have any quantitative data to support these so-called constituents' concerns when requesting County staff to research your next great idea?
- 4) Some advice for all Commissioners...go to uncomfortable places to hear real and genuine concerns if you truly believe in transparency or open-discussion and remember that it is very easy to criticize a decision until that same decision becomes yours.
