In responding to a communication from the Farm Bureau, and as long time farm owners and operators, we are OPPOSED to Charter Government for Charles County. Before granting these inept, farm hating Commissioners more power under a new form of government the following needs to be addressed and reforms initiated:

- 1. It is imperative that the issue of whether one of the Commissioners engaged in racial discrimination in possible violation of federal and state law needs to be addressed.
