Closed Session

At 5:15 p.m., a motion was made by Commissioner Patterson, seconded by Commissioner Bowling and passed, with all Commissioners present, voting in favor to move into Close Session where all or a portion of this session may be closed pursuant to Section 3-305 (b)(7)(10) of the General Provisions Article of the Annotated Code of Maryland to discuss and receive legal advice on public security issue. The reason for moving into closed session is to keep legal advice, and strategies confidential.

Summary Closed Session Items

3-305(b)(7)(10) Legal: Discussion on a Public Safety Issue

The Commissioners, the County Attorney and law enforcement personnel discussed public safety concerns in neighborhoods and potential ways to address these concerns especially for the upcoming Fourth of July holiday.

Discussion: Plan for Potential Neighborhood Nuisances During the Fourth of July Holiday

Mr. Wes Adams, County Attorney, Office of the County Attorney for Charles County; Charles County Sheriff's Office; and Town of La Plata Police Department and members of the Maryland State Delegation joined the Commissioners to discuss potential neighborhood nuisances during the Fourth of July holiday. Representatives from the Charles County Sheriff's Office and La Plata Police Department detailed their monitoring efforts to deal with any potential nuisance complaints brought by residents.

Mr. Adams reviewed the action taken in Prince George's County related to establishing a curfew at National Harbor due to over eight hundred (800) youth and destruction of businesses and safety issues. He opined that while the Commissioners have the legal authority to establish a State of Emergency, this would not address issues related to youth under the age of fifteen (15) in neighborhoods and does not rise to taking this level of action.

The Commissioners agreed that the issues related to the disruptive behavior in the neighborhoods does not rise to this level of action.

The Sheriff's Office indicated that they do have plans in place to address these potential disturbances and safety concerns, especially over the July 4th holiday.

The Commissioner agreed to begin holding joint meetings with partner agencies on safety concerns in the County.
