Call to Order/Pledge

Commissioner Collins called the meeting to order and began with the Pledge of Allegiance.

Roll Call

A roll call was taken. Commissioners Bowling, Coates, Stewart, and Collins were present in person. *Commissioner Patterson was absent.

*Commissioner Patterson joined session virtually at about 2:25 p.m.

Commissioners' Comments

Commissioner Stewart:

• Thanked Staff for continued updates during the August break.

Commissioner Bowling:

• Reminded everyone that this was the week of the Charles County Fair and that it was the one hundredth (100th) year anniversary of the Charles County Fair.

Commissioner Collins:

• Read the following statement:

"On behalf of the Charles County Board of County Commissioners, I want to provide a brief update to the public on a recent change to the status of the funding for the Southern Maryland Rapid Transit (SMRT) Project.

We recently learned through the release of the DRAFT Maryland Fiscal Year 2025-2029 Consolidated Transportation Program (CTP) that the available budget for this project was reduced from its previously funded amount of thirty(\$30M) million dollars to a two point one (\$2.1M) million dollars.

This proposed cut is significant and would be devastating to our attempts to bring much need rapid transit to Southern Maryland. The Board is particularly concerned that these cuts are potentially in violation of the State Transportation Article which mandates that:

'The State appropriate these funds to match federal earmarks, so that the Maryland Department of Transportation (MDOT) can PROMPTLY start and complete Environmental impact studying, planning, designing and engineering so that there is a record of decision.'

In fact, just this year, Charles and Prince George's County entered into a partnership with MDOT to complete the National Environmental Policy Act (NEPA) process and achieve a record of decision over the next two (2) years.

While we understand that the State is attempting to cut costs across state transportation programs, including Development and Evaluation projects, the SMRT project is different because the State Legislature passed a law that REQUIRES the State to fund it under a mandated formula.

Currently, that project has thirty (\$30M) million dollars allocated to its budget, which consists of ten (\$10M) million dollars in federal earmarks and twenty (\$20M) million dollars in State budget allocations. Additionally, there is another five (\$5M) million dollars in federal earmarks currently working its way through the federal appropriations process.

Just six (6) weeks ago, Senators Cardin and Van Hollen along with Congressman Hoyer were here in Charles County celebrating this latest earmark award of five (\$5M) million dollars, which, once allocated, would require the State to match with additional five (\$5M) million dollars in next year's budget.

In total, once all the earmarks are received, this project should be fully funded at forty (\$40M) million dollars. The Current DRAFT CTP appears out of compliance with the State Statutory mandate that this project be completed promptly. The transportation code contemplated that the State fund this project over a five (5) year period from 2023-2027 and not push it out to some undetermined time in the future.

It took years, even decades to get to this point with SMRT, our highest priority transportation project. Completion of the NEPA phase is simply not possible with a two (\$2M) million-dollar budget. We need to keep these dedicated federal and state matching funds in the transportation plan budget as it is essential for the County's efforts to build a resilient and sustainable community where every resident can thrive. On behalf of our County's Government and all of our residents, I urge state leaders to revise the draft transportation plan, because we are not just building infrastructure for Charles County with this rapid transit project – we are building a brighter future for all of Southern Maryland and our entire community."

Briefing and Request to Introduce: Proposed Bill 2024-(13) Zoning Text Amendment 24-184 Additional Transitional Provisions for the Waldorf Activity Center Zones
