# <u>Public Hearing: Docket 90 Amendment PDZA #24-90(23), Villages of Wooded Glen & Piney Reach Master Plan</u>

The Commissioners held a hybrid, virtual/in-person, public hearing on the proposed Docket 90 Amendments. Ms. Heather Kelly, Planning Supervisor and Mr. Charles Rice, Planning Director, Department of Planning and Growth Management reviewed the amendments which would relocate the proposed site of a Middle School from a location on St. Charles Parkway to an alternate site along Piney Church Road; it would also grant an exception to the eighty five percent (85%) rule, which requires no construction on the Villages of Piney Reach until eighty five percent (85%) of all residential buildings are completed in the Village of Wooded Glen; and the requirement for a vegetated buffer along MD Route 488.

There were twenty-one (21) people who presented in person comments and one (1) person who provided virtual comments.

A motion was made by Commissioner Stewart, seconded by Commissioner Patterson and passed, with all Commissioners present, voting in favor to keep the public record open for fifteen (15) days and hold a work session within thirty-five (35) days.
