

New Task Force Members


- Thomas Dennison SMECO

Atlantic Broadband

- Charles County Government staff met with Atlantic Broadband, a service provider in King George, VA and St. Mary's County.
- Want to gauge Atlantic Broadband's interest in providing service to any areas of Charles County.
- Atlantic Broadband drove around the county to survey unserved areas and is currently analyzing data to determine feasibility.

Update from SMECO

- Senate Bill 634 goes into effect October 1, 2019.
- SMECO has formed a task force to determine how best to move forward under the new legislation.
- SMECO representatives, county staff, and CTC met in August at the county Government Building
- CTC has requested GIS information from SMECO on the electrical system.

Broadband Strategic Plan

- CTC Technology & Energy is working on the development of our Broadband Strategic Plan.
- Conducted a kick-off workshop in June, bringing together various stakeholders from Charles County Government, Board of Education, Sheriff's Office, Public Library, College of Southern Maryland, Towns of La Plata and Indian Head, SMECO, and the Governor's Office.





Broadband Strategic Plan (cont.)

- CTC has conducted meetings with county staff and internal and external stakeholders:
 - SMECO
 - Reviewed SMECO's infrastructure and access requirements; discussed possible collaboration between SMECO and the County, as well as SMECO and local cable providers.
 - Local cable providers
 - Discussed possible partnerships between local providers and the County, as well as the next round of state and federal funding.
 - Chamber of Commerce
 - Provided overview of the project; Chamber representative outlined the need for, and value of, high-speed internet for businesses and telecommuters.
 - Parks Division
 - Reviewed County parks ownership as well as Program Open Space grant.

Broadband Strategic Plan (cont.)

- Additional meetings with CTC are scheduled throughout October:
 - Utilities Division
 - Planning & Growth Management
 - Emergency Services
 - Capital Services
 - Economic Development
 - Board of Education
 - Public Library
- County technicians have provided CTC analysts with data regarding all elements related to the project and continue to provide updated information on an ongoing basis.

Broadband Strategic Plan (cont.)

- CTC is reviewing the county's existing infrastructure assets.
 - Currently conducting desk surveys and analyzing data from the County and other sources.
 - Will conduct a field survey the week of October 7th.
- CTC has reviewed typical broadband construction costs within the county and is working on the Fiber-to-the-Premise (FTTP) sample design for the unserved areas.
 - FTTP will be the most expensive option and serve as a baseline for other, multi-faceted solutions to be proposed.
