NOW, THEREFORE, THIS AGREEMENT WITNESSETH: That for and in consideration of the sum of One Dollar (\$1.00) paid by the parties hereto to each other, receipt of which is hereby acknowledged; and of the premises, the mutual covenants and agreements herein undertaken, the said parties hereto agree as follows:

- 1. That the Owner by execution of this Agreement, does hereby convey title to said Facilities to COUNTY free and clear of all liens and encumbrances, and does further agree that it will execute any and all deeds necessary to convey to the COUNTY all easements for lines that now exist, and does further agree to grant such further easements for sewer and water mains, without charge, as may be determined by the COUNTY in its sole discretion, in order to serve the entire property of the Owner or connect same to other lines owned, or to be built, by the County or anyone.
- 2. That the Owner agrees to supply to the COUNTY all available information concerning the Testing and operation of the Facilities and warranties concerning the equipment in connection with this Agreement.
- 3. From and after date of the signing of this Agreement by the COUNTY, the COUNTY shall be Entitled to collect all fees of any nature for the operation of the Facilities on the subject site and agrees to become fully responsible for the maintenance of the system and service to the existing users.
 - 4. The Owner hereby warrants that it is the sole owner of said Facilities and that there are no

Outstanding liens against same, and does further indemnify and hold harmless the said COUNTY against any and all claims in any manner relating to its ownership, installation, or cost of the pipes and equipment covered by this Agreement.

5. The parties to this Agreement mutually agree that it shall be binding upon their respective
