First, given the revenue impacts from the current Covid-19 pandemic - i.e. significant increased unanticipated expenses, lost sales tax revenue, lost income tax revenue, potential reduced property assessments, etc., I strongly believe that it is irresponsible for the County's leadership to approve ANY increase in funding and recommend that the budget be frozen for ALL departments at the current levels.
