We need to expect more from developers in assisting with infrastructure prior to allowing communities that will strain our community. Our school system is beyond capacity at nearly every school. We are losing our standing as a progressive and desirable county in southern Maryland. Increasing development will only serve to expedite this drop in reputation.
