When I decided to purchase my current home 20-some years ago, I did so because it was located just a few miles from my workplace, yet far enough away from the business area to give me the peace and quite I love to come home to at the end of a day. The closest commercial business has always been a landscaping business located at 5405 Leonardtown Road. This type of business fits in with the area and provides a service that many of us use.
